On behalf of 62 undersigned organizations representing the Nursing Community Coalition (NCC), we commend you and Congress for introducing S. Res. 626 and H. Res. 1100, honoring and recognizing May 6 through 12, 2022 as National Nurses Week. These bipartisan resolutions underscore the indispensable care the more than four million Registered Nurses (RNs)<sup>1</sup>, Advanced Practice Registered Nurses (APRNs)<sup>2</sup>, nurse leaders, nursing students, faculty, researchers, and other nurses with advanced degrees, provide to patients across the country, especially during our current public health emergency.

The NCC is a cross section of education, practice, research, and regulation within the nursing profession and recognizes how vital our nursing workforce is to the health of our nation. As we work to provide substantial federal investment for nursing education, practice, and research, and address the pressing policy issues facing our country, we look forward to working with you as we continue to support our current and future nurses.
